- To support to Youth to taken up various skill development programs and create self employment


- To taken up programs on promoting of child rights

# A. Hand holding support to three FPOs:

The CRE is promoted three Farmers Producer Organizations (FPOs) in KV Palli, Kalakada and Kalikiri mandals with the objective of to create viable and sustainable farmer institutions to cater all types of needs of the member farmers. Each FPO has been conducting monthly once scheduled meetings, discussing the farmer issues and taking decisions. Each member paid Rs.1050/- to FPO (including Rs.1000/- for share capital, Rs.10/- for membership fee and Rs.40/- for shavings).

## A.1 Membership and share capital:

The following table depicts the FPO wise details of membership, share capital and savings.

There is a separate 9 member Executive committee for each FPO to take decisions on behalf of their members by due preference given to women representation in the Executive committee. Agenda based meetings are held and recording all the decisions to further dissemination to all members

#### A.2 Business activities of FPOs:

All three FPOs were established business centers for sale of cattle feed, sprayers, tarpaulins etc to their member farmers. The FPOs are selling the products low rates compared to local dealers with high quality standards.

## A.3 Trainings to FPO BoD members:

The CRE is provided training to FPO Board of Directors on 6 self-learning modules to strengthen their activities recommended by NABARD. They are importance of

FPOs, membership at FPOs, services of FPOs, roles and responsibilities of EC, financial management practices, bylaws and legal compliances. They are able to maintain their FPOs on their own.

## A.4 Customer hiring centers:

Providing hand holding support for managing of Custom Hiring Centers (CHCs) in three Mandals. The CRE is established these centers with an investment of Rs.10.00 lakhs per FPO. Each center has Agricultural machineries & equipments like tractor, cultivator, rotator, seed cum fertilizer driller, power weeders, Taiwan sprayers, harvester, Brush cutters are kept available to access the small and marginal farmers with nominal rental basis to utilize in their agriculture field and reduce their input cost of cultivation. The price list of services available in each custom Hiring center is displayed to create transparency in all activities and to get confidence among the member farmers. Every month the each FPO is getting Rs.10,000 profit from the CHCs

### B. Watershed Activities at Vadlakunta sanctioned by NABARD:

The NABARD has sanctioned Vadlakunta watershed at KV palli mandal of Annamayya district of Andhra Pradesh. Vadlakunta is aremote village where there are no developmental activities taken place. Most of the farmers are depended on rainfed agriculture particularly ground nut.

The CRE is formed a watershed committee with 13 pro-active farmers from different social categories. The CRE is taken up the following activities in watershed area

- Capacity Building Plan is prepared and submitted to NABARD
- Organized exposure visit to Palamaner sheep rearing center for the benefit of committee members
- Organized exposure visit to Regional Agricultural Research stations activities on ground nut at Tirupati
- Organized exposure visit to watershed activities at thavvavandlapalli where NABARD promoted watershed activities are in progress and yielding good results.


#### C. Gender:

To encourage women in the developmental activities, the CRE is encouraged women to join into FPOs. 37% of FPO members are women. Preference given to

women in Executive committees of FPOs. Identified women from pop families to provide support for local breed poultry and night shelters.
